General note on usage restrictions for this Collection of Addons for the Arma game engine.

This note explains that there are <u>legally-binding restrictions</u> on how you use this Addon.

The Author of the Addon may permit you to use the Addon through their personal communications with you directly, or through an End-User Licensing Agreement (EULA) included with their work.
